**Vilas County Releases Results of 2019 WI Wins Compliance Checks**

The Northwoods Tobacco-Free Coalition (NWTFC) conducts annual Wisconsin Wins compliance checks. Compliance checks are done to ensure local retailers comply with the law by not selling tobacco and nicotine products to minors. After completing randomized checks this year, we are excited to announce 94% of Vilas County’s retailers choose not to sell tobacco products, like cigarettes, cigarillos, and chewing tobacco, to minors! A total of 32 random checks were completed in Vilas County with 2 stores selling to minors.
